GUIDELINES FOR BUSKING

Busking is allowed between the hours of 9:00am to 9:00pm Monday to Friday, and between 9:00am and 5:00pm Saturday and Sunday.

THE PERMIT:

- Is valid for 3 months from the date the permit is issued (unless dated)
- Is not transferable
- May be suspended/cancelled by Council at any time and any reason
- Must be carried by the person whilst performing

PERMISSION IS SUBJECT TO THE FOLLOWING CONDITIONS:

- 1. You do not interfere with any other busking acts that are performing at the same time as you
- 2. You do not create any nuisance
- 3. A break of 10 minutes is to be taken following 20 minutes of concentrated play
- 4. Location should change during the 10 minutes break
- 5. The permit holder shall not advertise or associate himself/herself with advertising in conjunction with any performance
- 6. No article or commodity is to be sold, or offered or exposed for sale
- 7. The use of amplifiers is prohibited
- 8. You obey any direction given to you by a member of the Victorian Police or an Authorised Council Officer
- 9. You do not interfere with members of the public
- During festivals or events you (unless invited by Council) will not be permitted to perform at that location
- 11. If the applicant is under 18 year of age, it is the responsibility of the consenting parent or guardian to decide if supervision of the applicant is required at the time of performance, taking into account the vulnerability of the applicant.

Non-compliance with any of the above conditions may result in the immediate revocation of the permit.

The permit is issued under the provisions of Maribyrnong City Council General Purposes Local Law Part 2 Section 11
